o **Review of In-Semester Funding Requests**

▪ **Capoeira Senzala**

- Seeking \$950 for t-shirts; 100 t-shirts for \$9.50 each. A complete application was submitted.

▪ **University of Hawaii at Mānoa Band Request**

- UHM marching band requested \$9800 of funding.
- UHM band was funded for trips, the rainbow invitational for transportation and bentos.
- \$4,917 received from SAPFB to repair their instruments.
- The following funding was approved:
  - o Repair of instruments - \$0
  - o Duplication - \$1500
  - o Music Rights/Copy Cat - \$600

  - o Visual/Choreography Design - \$900
  - o Drill Writer - \$2000
